ACKNOWLEDGMENT AND ACCEPTANCE OF RISKS AND LIABILITY RELEASE**

In consideration for being allowed to participate as part of the **Canis Lupus Challenge** (“The Event”)

I, the “Participant”, (“THE UNDERSIGNED” means only the PARTICIPANT when the PARTICIPANT is age 18 or older **OR** it means both the PARTICIPANT and the PARTICIPANT’S parent or legal guardian when the PARTICIPANT is under the age of 18.) _____ understand, agree to and except the following:

WARNING: All forms of Alpine and other related mountain activities are hazardous – your safety is directly affected by your judgment. Ride/Ski only within your ability. Be alert to the many risks of the sport including, but not limited to changing weather, visibility and surface conditions, man-made and natural objects, snow vehicles, design, and condition of natural and man-made features.

Competitive Snowboarding/Skiing has numerous risks including, but not limited to falls associated with the use of natural and man-made snowshapes, severe terrain changes, equipment failure, hard or uneven landings and collisions with other competitors, spectators and natural and man-made objects.

In consideration of allowing the Participant to participate in the EVENT, THE UNDERSIGNED hereby agree to **ASSUME ALL RISKS** associated with the PARTICIPANT’S participation in the EVENT. Additionally, THE UNDERSIGNED agree to **HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY**, ASC Utah dba The Canyons, its affiliated organizations and companies, and its insurance carriers, parent, agents, employees, representatives, assignees, officers, directors, and shareholders (each hereinafter a “RELEASED PARTY”) for **ANY AND ALL LIABILITY** and/or claims for injury or death to persons or damage to property arising from the PARTICIPANT’S participation in the EVENT, **including those claims based on any RELEASED PARTY’S alleged or actual NEGLIGENCE OR BREACH OF any express or implied WARRANTY**. The UNDERSIGNED understands and agrees that The Canyons is providing access to its terrain to the Summit Ski Team to train and race in exchange for their acceptance and acknowledgement of full liability and responsibility for an injury, death or damage caused by or to Participant or arising out of Axis Freeride and its members’ use of The Canyons by them.

THE UNDERSIGNED further agree and understand that risks associated with the EVENT, in addition to those previously listed, include, but are not limited to: equipment malfunction; surface conditions; marked and unmarked obstacles; rugged mountainous terrain; slick or uneven riding and walking surfaces, surfaces covered with ice and snow; strenuous activity; high elevation; falling; avalanches; cornices suffocation; sharing ski area facilities and EVENT venues with people directly involved and/or not directly involved in the EVENT. PARTICIPANT understands and acknowledges he/she has been informed and understands all rules and regulations of participating in the EVENT. PARTICIPANT is responsible for reading, understanding and complying with all signage, including instructions on the use of the lifts. PARTICIPANT recognizes that he/she must have the physical dexterity and knowledge sufficient to safely load, ride and unload the lifts. PARTICIPANT may use the ski lifts without an adult present. Participant assumes the risks of riding the lifts and engaging in activities accessible from the lifts. PARTICIPANT understands that snowmobiles, snowmaking, snow-grooming and EVENT preparation equipment may be encountered at any time. PARTICIPANT recognizes that falls and collisions occur and injuries are a common and ordinary occurrence of the EVENT.

If participating in a competition I understand that I may take the opportunity to inspect the venue prior to participation.

I understand that the use of Helmets is strongly encouraged.

In consideration for allowing the PARTICIPANT to participate in the EVENT and for using the ski area facilities, THE UNDERSIGNED agree that **ANY AND ALL CLAIMS** for injury and/or death arising from the PARTICIPANT's participation in the EVENT shall be **GOVERNED BY UTAH LAW** and **EXCLUSIVE JURISDICTION** of any claim shall be in the **DISTRICT COURT residing where the alleged incident occurred or in the FEDERAL COURT FOR THE STATE OF UTAH**. Recognizing the risk and dangers, the undersigned understand the nature of the activity and voluntarily choose for participant to participate in and expressly assume all risks and dangers of the activity, whether or not described above, known or unknown, inherent or otherwise.

In the case of a minor PARTICIPANT, the undersigned parent or legal guardian acknowledges that he/she is also signing this release on behalf of the minor PARTICIPANT and that the minor PARTICIPANT shall be bound by all the terms of this release. Additionally, **by signing this release as the parent or legal guardian of a minor PARTICIPANT, the parent or legal guardian understands that he/she is waiving certain rights on behalf of the minor that the minor otherwise may have**. The undersigned parent or legal guardian agrees that but for the foregoing, the minor would not be permitted to participate in the EVENT. The undersigned parent or legal guardian also agrees that if the PARTICIPANT is injured, the parent or legal guardian authorizes medical care for the PARTICIPANT and/or transport of the PARTICIPANT to a medical facility at the parent/legal guardian's expense. No provision in this Release shall create a duty to provide medical care or transportation to any PARTICIPANT. The furnishing of medical care is neither an admission nor an assumption of liability by the Released Parties.

THE UNDERSIGNED give Resort permission to take and use photographs, video recordings, or movies of PARTICIPANT taken during an EVENT for any purpose in promoting the RESORT or related activities of the RESORT in print, brochures, advertisements, films or videos and on broadcast presentations of any sort.

By signing this release without a parent or guardian's signature, the PARTICIPANT represents that he/she is at least 18 years of age, or, if signing as the parent or guardian of the PARTICIPANT, you represent that you are the **legal** parent or guardian of the minor PARTICIPANT.

THE UNDERSIGNED agree and understand that this release is applicable to each and every day PARTICIPANT participates in the EVENT.
